Pennsylvania firm leaders have always prioritized measured growth, but firm leaders this year reported softening interest in mergers and launching new offices. The outlook comes in the face of rising costs, shrinking revenue margins and increased difficulty collecting on outstanding bills.

Pennsylvania's midsize law firm market underwent the most significant changes in 2023, with two mainstay litigation firms closing its doors. Although many said the closures were the product of longstanding trends, firm leaders tended to agree that market forces are pushing many midsize firms to find dynamic practice mixes and client bases if they want to survive in today's rapidly changing market.

However, despite the uncertainty and gloomy outlook on the business side of things, courts and litigators found themselves busier than ever as cases that were left lingering during the COVID-19 lockdowns began hitting the trial phase in 2023. And they show no sign of stopping any time soon.

In these pages, we aim to provide the numbers and statistics underlying these trends, in the hopes that learning from the past can help us bring at least a little more stability to our future.

On a separate note, this will also be our last edition in print, although we will continue to provide all the same content—and interactive too!—online. The move, which is taking place across most ALM publications, has been a long time coming as the media business has continued to head in this direction for years. But by allowing ourselves to focus exclusively on our digital delivery of the content, we are confident the move will prove highly beneficial to you, the soon-to-be online reader.

For now, inside these pages, you'll find all the great content you've come to expect from this magazine, including Pennsylvania's 100 Largest Law Firms and Largest Verdicts & Settlements lists, and the results of our 29th Annual Managing Partners Survey.

Motion granted in part, motion denied.

Defendant sought summary judgment in plaintiffs' personal injury suit, in which plaintiff alleged he suffered a heart attack from acute emotional stress from being in proximity to the catastrophic failure of defendant's negligently-maintained power equipment. The court denied summary judgment.
5	<i>McClure v. Loves Travel Stores &amp; Country Stores</i>	23-0662	U.S. District Court for Pennsylvania - Middle	05/23/2023	Kane, J.	Defendant moved for summary judgment in plaintiff's slip and fall action and court found plaintiff failed to identify the cause of his fall, to show defendant had actual or constructive notice of a dangerous condition or to show defendant failed to maintain its premises. Motion granted.

Motion granted.

# Pa. Firm Leaders Turn Cautious Following Years of Optimism, According to Survey Results

The optimistic outlook that fueled many firm leaders in the first few years coming out of the pandemic is turning into one of caution.

According to Pennsylvania’s 2023 Managing Partner Survey, growth has not been as robust as it was in recent years, and as a result fewer firm leaders say they are expecting to see significant merger activity, revenue growth or law firm expansions in the coming year, indicating that managing partners are more interested these days in holding the line.

The more tentative outlook comes following a period of big change for Philadelphia’s legal market, which saw the loss of two legacy firms since the start of the year.

At the beginning of 2023, Detroit-based, Am Law 200 firm Clark Hill announced it would be absorbing Conrad O’Brien, marking the end of a highly regarded litigation firm that had been a mainstay for the local market for nearly 40 years. Six months later, Schnader Harrison Segal &



the city’s legal community is facing new economic realities of rising costs and shifting market pressures, which have been particularly hard for midsize firms to absorb, with some managing partners saying Pennsylvania firms must adapt if they want to remain independent.

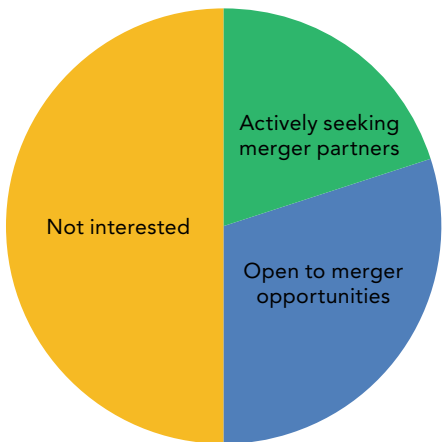
Many of those sentiments were borne out in the latest survey results, which show firms leaders are taking a measured approach and are not as interested in growth in the face of rising costs and uncertainty.

For this year’s survey, we had a robust response from firm leaders, with 33 participants, up from 25 firm leaders in years past. Participants came from a broad range of firms, with 10 coming from firms with 25 attorneys or fewer, 14 from firms with between 26 and 200 lawyers, and nine from Big Law. Participants also split evenly between those describing themselves as full-service, and those calling themselves specialized, or boutique.

According to the respondents, when it comes to growing headcount, more firms are looking to hold steady than in previous years.

According to the results, the number of firms reporting have seen significant

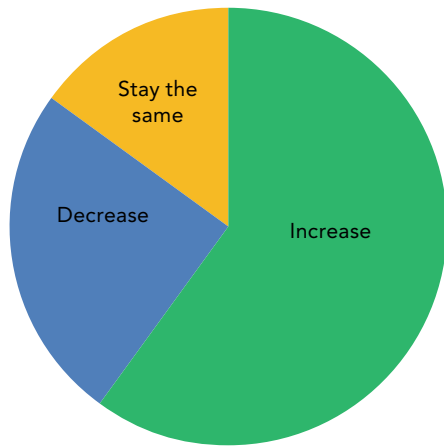
headcount growth steadily dip in recent years, from 50% in 2021, to 25% in 2022, with only 17% of respondents reporting headcount gains from the previous year. Although 45% of firm leaders said they saw slight growth, the number of managing partners saying their headcount stayed

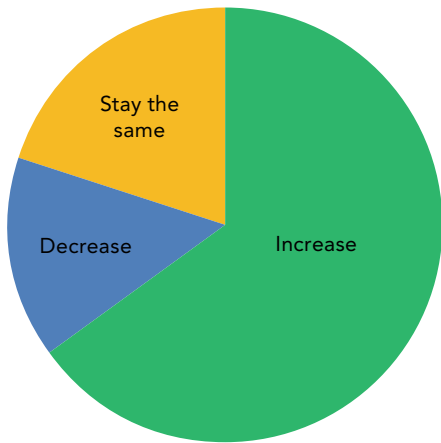
**Firm Net Profits**

the same has increased, rising from 7% last year to 31% this year.

On the positive side, slightly fewer firm leaders reported having shrunk compared to last year. All the firms reporting reductions said they let go both attorneys and staff, and that all reductions were no larger than 5% of the total employee headcount.

Interest in mergers has shrunk as well. In last year's survey, 32% of firm leaders reported that they were actively seeking a merger partner. However, this year, slightly less than 18% reported the same. The results align more closely with the 2020 results, where 17% of managing partners reported actively seeking a merger. Fewer firm leaders also reported being open to the possibility of a merger, with 32% this year, down from 48% last year.

Of those seeking a merger, firm leaders split nearly evenly between whether they are looking to expand within the state, regionally or outside of the region.

When it comes to a law firm's individual footprint, fewer firm leaders also reported opening new offices compared to last year, dropping from nearly 58% reporting having expanded in the previous year to fewer than 28% reporting having opened new offices this year—numbers that closely align with the 2021 survey results when 30% reported new office openings. The number of firm leaders also saying they plan to open new offices next year ticked down as well, from about 40% in the past to surveys to less than 28% this year.

More than 41% of firm leaders also said they were planning to downside their office

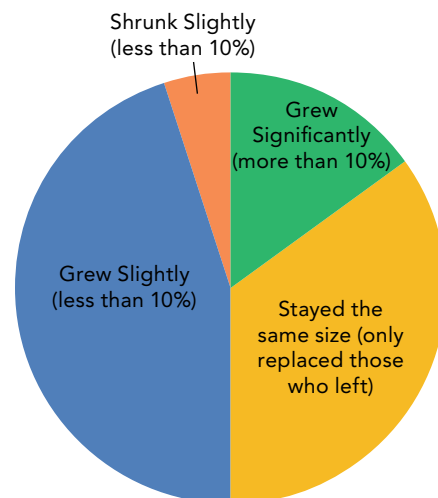
footprint in the coming year, although only slightly more than 3% said they planned to close an office entirely.

The cautious outlook jibes with what firm leaders said about their revenues this year. Fewer reported seeing revenue increases than at any point since the pandemic, with fewer than 69% saying they saw increases. Going along with the theme, nearly 14% reported seeing revenue decrease, while 17% said it stayed the same—both of which were at their highest levels since at least 2020. Those figures matched what firm leaders reported regarding revenue per lawyer as well, marking the first time in at least three years that firm leaders reported decreases in RPL.

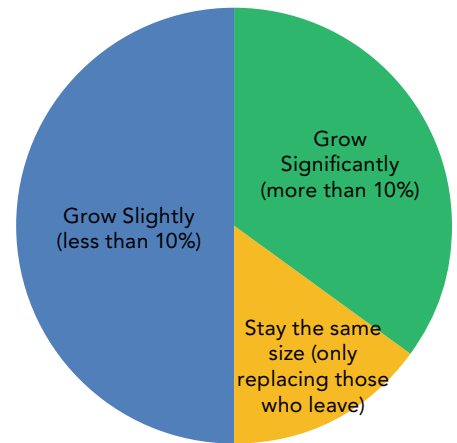
And while revenue has tapered off, more than 80% of firm leaders also said costs are increasing, leading to a large increase in the percentage of managing partners reporting decreases in net profits. For this year, 27% of firm leaders saw decreased profits, up from just 4% last year. In total, less than 59% of firm leaders reported increased revenues compared to more than 90% last year, and nearly 89% before that.

As cost drivers, most firm leaders said their technology budgets increased significantly in the past year, while only a handful said the same thing about their marketing budgets. Firm leaders also indicated that associate salary increases are leveling off, after 92% reported boosting associate-level pay last year.

To offset the increasing costs, firm leaders once again reported leaning most heavily on increasing billing rates.

However, further complicating matters, firm leaders also reported having a harder time collecting this year than in the past few years. This year, more than 8% of firm leaders reported clients who frequently demand reductions. No firms reported having that trouble in the past three years.

## ODDS AND ENDS

For the second year in a row commercial litigation was the practice group firm partners expect will see the most growth in the coming year. Other expected top sources of work this year include labor and employment, bankruptcy, white collar and personal injury. In terms of where firm leaders expect to see decreases in activity, responses split this year between mergers and acquisitions and real estate and land use planning.

The 2023 survey also saw a steep drop in the number of firms reporting that they have diversity initiatives, down from 92% last year to 58% this year. Fewer firm leaders also reported receiving inquiries about the number of minority and female attorneys. Some firms—almost 7%—also reported having lost clients over diversity-related considerations. No firm leader reported having lost work over diversity over at least the past three years.

At 3.5%, fewer firms also reported allowing fully remote work after 15% of firm leaders reported allowing the practice last year. Leaders also reported a seemingly related boost in the number of firms requiring one to two office days per week, while roughly the same percentage—7%—reported requiring all five days in the office.

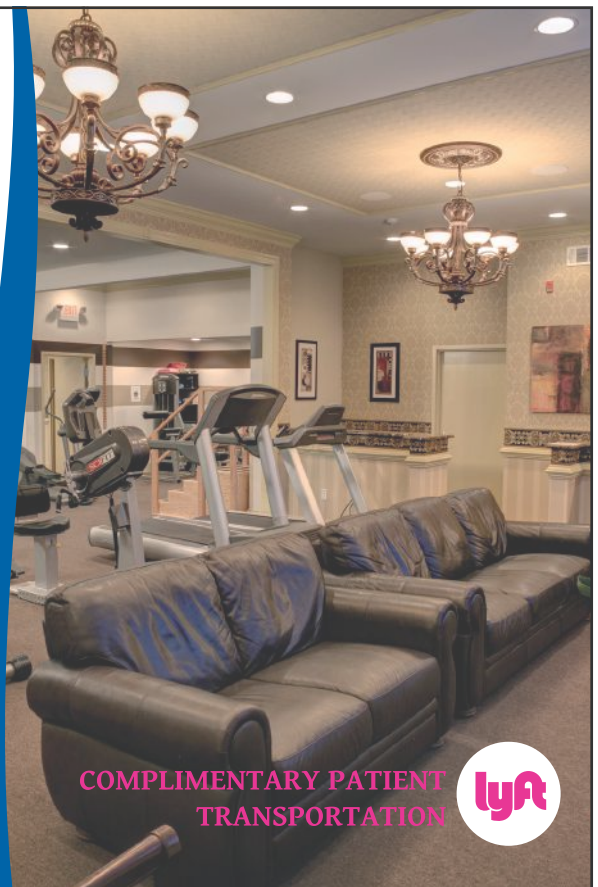

# Transactional Turbulence Made 2022 a Mixed Bag for Pennsylvania Firms

Dips in transactional work translated into a mixed-bag of financial results for Pennsylvania's Am Law 200 firms in 2022, as they returned to reality after 2021's glut of hiring, transactional work, and revenue increases.

For those handful of local firms who managed to remain steady or find incremental growth during the year, balance in practice area offerings and headcount proved crucial to stabilizing end of year financial results. For those unable to find a balance, however, 2022 marked the beginnings of a turbulent transactional market, with 2023 sowing seeds for further disruption, given return to office struggles and rising interest rates.

## MORGAN LEWIS & BOCKIUS

Morgan Lewis was a notable winner in 2022, eking out the highest increase in gross revenue in the region and inching ever-closer to the \$3 billion mark as well as the highest revenue per lawyer amongst its Pennsylvania-based colleagues.

The firm found a solid balance between increasing its revenue by 6.5% to rest comfortably at \$2.74 billion and growing its headcount, adding on 44 attorneys while maintaining positive growth for both revenue per lawyer and profits per equity partner. RPL increased by 4.2% to \$1.34 million while PEP increased by 4.4% to \$1.9 million, ending the year with a 54% profit margin.

## REED SMITH

Despite the year's transactional headwinds, Reed Smith held steady financially, balancing its attorney spread with increased demand for trial work as transactional demand began to sour. The firm saw slight decreases to its revenue and headcount, dropping by 1.3% and 2.1% respectively,



while it managed to boost revenue per lawyer by 0.9% to \$921,000.

However, the firm's drop in revenue to \$1.4 billion was most felt in its profits per equity partner figure, which decreased by 5.2% year over year to \$1.64 million, although the firm's PEP was the third highest in the region.

## DECHERT

Perhaps best encapsulating the instability of the legal market on recent years is Dechert, which followed up its 50% profitability boost from 2021 with a 14% drop in profits per equity partner and 4% drop in revenue in 2022. The firm, which benefited from a glut of demand for transactional and investment services in the prior year, saw a slowdown in capital markets related work in the second half of the year, indicative of the volatility of the market when it comes to cyclical practices.

However, analysis across the Pennsylvania firms shows that Dechert maintained the highest profits per equity partner, despite the 14% drop, at approximately \$3.6 million. The firm saw more modest drops elsewhere, with gross revenue dropping 4% to just under \$1.3 billion and revenue per lawyer dropping 8.4% to \$1.325 million.

## K&L GATES

Global firm K&L Gates had a relatively flat performance financially compared to 2021 with a modest increase in gross revenue, about 1.5% to \$1.2 billion. The firm increased its headcount by about 2.8% for a grand total of 1,746 attorneys, a slight increase that had the firm's profits per equity partner increase by 3.7% to \$1.4 million.

However, the firm's revenue per lawyer dropped by 1.2% to \$686,000, the third lowest among Am Law 200 firms rooted in the state, and profit margins dipped by 1% down to 21% year over year.

## TROUTMAN PEPPER HAMILTON & SANDERS

Coming out of its second full year as a combined firm, Troutman Pepper obtained net gains across the board in terms of profits per equity partner, gross revenue, and revenue per lawyer, achieving a 12.4% increase in PEP by de-equitizing some of its partners.

The firm's gross revenue grew by 5% to \$1.08 billion, with firm leaders linking their success to avoiding 2021's overhiring spree and maintaining a balance between its transactional, litigation, and

regulatory headcounts. The firm also saw revenue per lawyer increase by 5.2% to \$965,949.

### FAEGRE DRINKER BIDDLE & REATH

Another firm born out of a 2020 merger, Faegre Drinker saw a drop in revenue that firm leaders attributed to the softening of the corporate and transactional markets. Net income for the firm also fell by 8.7%, a result of the resurgence of costs the pandemic trimmed dramatically, such as travel. Gross revenue dropped by 3.3% to \$9.5 million, falling just short of the \$1 billion mark, yet revenue per lawyer increased by 1.7% to \$919,000 and profits per equity partner increased by 0.6% to \$990,000.

Contributing to these increases was a shrink in headcount and equity partnership, with the firm's total headcount declining 5% to 1,039 attorneys, an overall 9% dip since the combined firm's inception, and a 6% decrease in its partnership.

### FOX ROTHSCHILD

Fox Rothschild had a turbulent year in 2022, increasing gross revenue by 2.8% to \$668 million, not enough to offset the firm's 28 attorney increase in headcount. Revenue per lawyer dropped by a modest 0.4% to \$734,000, while profits per equity partner staggered down by 8.9% to \$849,000, reflective of a 2.9% increase in the size of the equity partnership and a 14.4% increase in associates.

### DUANE MORRIS

Following an aggressive hiring spree in the fourth quarter, Duane Morris saw a slight decline in profitability despite increasing gross revenue by 5.8% to \$631.3 million, one of the highest increases in the region.

In addition to facing the rocky transactional market, the firm brought on an additional 49 attorneys in the final quarter of the year, contributing to a 2.9% decrease in profits per equity partner down to approximately \$1.23 million. Despite the overall increase in headcount, however, the firm increased its revenue per lawyer by 4.9% to \$865,000.

### COZEN O'CONNOR

Strength in commercial litigation, continued investment in niche practices, and well-performing subsidiary companies aided Cozen O'Connor in 2022, helping the firm net a 5.9% increase in gross revenue hitting \$6.19 million. The firm's rapid development of its Canadian outpost also contributed to the firm's decent financial performance, adding about \$15.66 million to the firm's bottom line.

The firm's headcount increased by 3.5% to a total of 726 attorneys, which drove smaller increases in revenue per lawyer and profits per equity partner. Revenue per lawyer increased by 2.2% to \$852,000 while profits per equity partner increased by 1.8% to \$1.1 million.

### BLANK ROME

Defying trends in 2022, Blank Rome's real estate and corporate deals helped the firm achieve double digit increases in profitability for the second year in a row, a feat other local firms were hard-pressed to achieve. Opting to prepay expenses and clamping down on expenses, the firm's revenue increased by 6% year over year to \$5.8 million while profits per equity partner shot up 10.2% to \$1.35 million. Headcount modestly increased by 2.4% or 14 attorneys, while revenue per lawyer grew by 3.5% to \$989,000.

### BALLARD SPAHR

Ballard Spahr's financial performance remained relatively flat over 2022, seeing modest revenue growth at 3.5% to hit \$482.2 million despite mid-year increases

to associate salaries and a fourth quarter transactional halt. Revenue per lawyer decreased by 0.1%, while profits per equity partner decreased by 0.4%, reflecting minimal changes for the firm between 2021 and 2022.

### BUCHANAN INGERSOLL & ROONEY

Buchanan also experienced a relatively flat financial year with a 1.2% decrease in revenue to \$293.5 million. Despite a 6.75% increase in the firm's attorney headcount between 2021 and 2022, revenue per lawyer increased by 0.5% to \$714,000 and profits per equity partner increased by 0.9% to \$855,000, explained by a 5.1% decrease in the firm's equity partnership tier.

### SAUL EWING

Saul Ewing took a hit to profitability in 2022, with profits per equity partner dropping by 11.7% from \$809,000 to \$714,000, nearly wiping out its 14.8% gains from 2021. The firm's equity partnership tier increased by 3.5% in 2022 while its non-equity partnership decreased by 9%, explaining the profitability drop even as gross revenue shrunk by a marginal 0.5% to \$256 million. The firm's revenue per lawyer increased by 0.3%, reaching \$730,000.

### MARSHALL DENNEHEY

Marshall Dennehey also took a hit to profitability in 2022 despite seeing increases in revenue and a decrease in headcount, with profits per equity partner dropping by 3.8% to reach \$382,000. The firm's gross revenue increased by 3.7%, hitting \$235.4 million, while revenue per lawyer increased by 6.6% to \$501,000.

### ECKERT SEAMANS CHERIN & MELLOTT

Eckert Seamans concluded 2022 with a decrease in both gross revenue and profits, losing 5% of revenue to end around \$139.6 million. Revenue per lawyer increased by 1% to \$495,000 while profits per equity partner shrunk by 3.6% to \$457,000. ●

# TEMPLE HOSPITAL FACES \$30M JUDGMENT

**Jury Hands Up \$2.7M
